## **MBAG GOLD AWARDS 2009: IMPORTANT INFORMATION-PLEASE READ!!**

Please read and understand the following instructions to complete your submission correctly.

1. **CREDITS:** The MBAG office does not track credits for local chapters outside of Atlanta. The Atlanta chapter contracts with the management office for management services; therefore, only Atlanta chapter and state-level credits are tracked at the MBAG office. If you have additional credits earned at the MBAG State-level, you should have received a state-level report card with those credits filled in. You must complete both the form for Chapters and for state credits, **and include both forms with your submission.** Contact your chapter president or the MBAG office for assistance in obtaining either form, or consult the MBAG website. You need only pay one nomination fee/ GGF contribution.
2. **GOOD GOVERNMENT FUND (Formerly 101 pin):** The GGF 101 pin has been retired. However, you still need to make a contribution of at least \$100 to the Good Government Fund to qualify. **You will not receive a pin.** At present, there are no plans to reintroduce the pin to the program. If paying by check, please make your contribution payable to “**MBAG Good Government Fund**” or “**MBAG GGF.**” The December 31 deadline will not be enforced this year, but your contribution must be received before award status will be granted.
3. **NOMINATION FEE:** Every qualifying loan officer must remit a \$100 nomination fee to be eligible for Gold Awards. Some companies may choose to pay this fee for their employees; others may not. Please consult your supervisor for a determination. In any case, the nomination fee must be submitted before eligibility for award status is granted.
4. **PRESIDENT’S AWARD (IF APPLICABLE):** If you have met the requirements for President’s Award (consult your report card for details,) please enclose your check, made payable to “**MBAG Foundation**” with your submission. All requirements subject to verification.
5. **PHOTO:** Each Gold Award winner should submit a headshot for inclusion in the newspaper publication, as well as for the awards ceremony and MBAG website. If your photo is not currently on file with MBAG, please provide one ASAP via email.
6. **AWARDS CEREMONY:** Attendance at the annual awards ceremony **IS NOT INCLUDED** with your nomination fee. This event requires SEPARATE REGISTRATION and FEE to participate. Details will be published on the **MBAG website** as soon as they are finalized.
